#### Office Order

With a view to streamline internal working and to build and harness domain expertise, it has been decided to adopt a team-based approach to technical functioning of the Authority. For this purpose, Technical Officers working in Standards, Regulations, Product Approval and Codex Divisions are assigned to teams by food category as per the <u>Annexure 1</u>.

- 2. Teams would report to the respective Divisional Heads through officers assigned for respective functions. In addition, they will also be responsible for surveillance, risk assessment, implementation of Food Safety Management System (FSMS) and training and capacity building of food businesses in respect of such businesses that are closely aligned to the food categories handled by them. Teams will discharge the following functions:-
  - (i) building a database with contact information of members of related scientific panels, codex committees, other experts in government ministries/agencies, academic and research institutions, food businesses and related community based organizations and associations. For seamless flow of information amongst the members of this community, Team coordinator will create a WhatsApp group as per naming scheme given in the **Annexure 1**.
  - (ii) collecting and compiling information on national standards, codex and other international standards and identify gaps in standards in related areas.
  - (iii) processing of new product approval proposals and developing standards in respect of product categories for which approvals have been given in the past.
  - (iv) preparing a work plan on development of new standards and revision of existing standards in their respective areas. Such plan will be reviewed every month based on feedback received by the group either from enforcement division and other divisions or through representations to the Authority or through media reports or social media.
  - (v) preparing overall plans for surveillance and risk assessment activities, FSMS implementation, training and capacity building and consumer advocacy activities to be taken up in their areas with specific deliverables.

- (vi) field visits and continuing education programme (s) to enhance their domain knowledge and understanding.
- 3. Each team will have a Coordinator and senior officer as Mentor. To begin with the Coordinators and Mentors for each team have been assigned as per details at Annexure I. However, after a month, each team is expected to select one of its team members as Coordinator, identify an officer from the Authority as Mentor and also identify an external Mentor.
- 4. The work of the teams and individual officers based will be periodically evaluated on the basis of the value added to the food safety ecosystem in the country. There will be weekly meetings of the Coordinators.
