Ltd., New Delhi (FSSAI Reg No. 3/N/FSSAI/2014 and NABL TC-5361) was recognized and notified by FSSAI in the Gazette Notification vide S.O. 3648 (E) dated 06th December, 2016 for chemical and biological scope of testing for the purpose of carrying out the analysis of food sample under Food Safety and Standards Act, 2006 and Rules and Regulations made thereunder.

- 2. It is noted that M/s Sophisticated Industrial Materials Analytical Labs Pvt. Ltd., New Delhi has been denied for accreditation/recognition and debarred by NABL from re-applying.

Ltd., New Delhi is hereby suspended w.e.f. 20th November, 2021, from carrying out analysis of samples under the Food Safety and Standards Act, 2006 and Rules and Regulations made thereunder for a period of not less than six months or till the 'debar from reapplying' status of NABL is valid, whichever is earlier, as per the clause (iii) of sub regulation (1) of Regulation (10) read with the sub-regulation (2) of Regulation (10) of Food Safety and Standards (Recognition and Notification of Laboratories) Regulations, 2018.
