M/s National Commodities Management Services Limited - CommGrade - Testing Services Regional Laboratory, (North), Gurugram, Haryana bearing FSSAI Reg. No. 52/N/FSSAI/2018 and NABL Certificate No. TC-6507 was recognized and notified by FSSAI u/s 43(1) of FSS Act, 2006 vide Gazette Notification S.O. 848 (E) dated 19th February, 2018 and subsequently, amended vide Gazette Notification dated 31st January, 2022, for chemical and biological scope of testing for the purpose of carrying out the analysis of food sample under Food Safety and Standards Act, 2006 and Rules and Regulations made thereunder.
