Subject: Mandatory use of FSSAI test methods for testing of fortificants (Iron, Vitamin B9 and Vitamin B12) in Fortified Rice, Fortified Rice Kernel and Vitamin-Mineral Premix for Fortified Rice Kernel- reg.

All the FSSAI notified Food Testing Laboratories approved for testing of fortificants (Iron, Vitamin B9 and Vitamin B12) in Fortified Rice (FR), Fortified Rice Kernel (FRK) and Vitamin-Mineral Premix for Fortified Rice Kernel vide orders issued from time to time (recent order dated 3rd June 2024), are directed to mandatorily use FSSAI approved test methods only, published vide orders dated 8<sup>th</sup> September 2022, 7<sup>th</sup> November 2023 and 9<sup>th</sup> November 2023. The details of these methods are summarized below for reference:

- 3. The laboratories which will fail to comply with the above mentioned directions will be delisted/ removed from the approved list of laboratories for testing of fortificants (Iron, Vitamin B9 and Vitamin B12) in FR, FRK and Premix for FRK.
- 4. This issues with the approval of the Competent Authority.
