No. 91/S/FSSAI/2024)' with the scope of accreditation 'Chemical'. The current scope of accreditation by National Accreditation Board for Testing and Calibration Laboratories (NABL) for the said laboratory covers testing of prohibited substances (currently 64) declared by WADA under the discipline 'Chemical-Nutritional Supplement' (enclosed).

In view of the above, it is to inform that enforcement authorities may also utilize the aforementioned notified laboratory for testing of 'Food for Sportsperson' with FSSAI license for prohibited substances declared by WADA (as per existing scope & accreditation of the laboratory), as and when required.
