C. Other Projects:

1. Development and launch of **Food-o- copoeia** Portal on 20/07/2023. Food- ‘O’-copoeia is a collection of food category-wise monographs which is a single point reference for all applicable standards for a specific product category specifying quality & food safety standards, labelling and claim requirements, specific packaging requirements and many more.
2. Development and launch of **Common Digital Dashboard**. Common digital dashboard is a platform wherein regulators and commodity boards across India exchange perspectives on strengthening Food safety systems and regulatory framework as a cohesive approach.
3. Development and launch of **SaNGRAH**. SaNGRAH is conceptualized to facilitate domestic and overseas exporters, importers, manufacturers, traders etc. This portal provides the information about the Food Regulatory Authorities of various countries across the world, their mandate, food safety ecosystem, food testing facilities etc. at one platform.

SOCIAL AND BEHAVIOURAL CHANGE DIVISION

1. In the month of July 2023, a total of 137 social media posts were designed and circulated for creating public awareness through different social media platforms of FSSAI.

3. Eat Right Millets Melas and walkathons/cyclothons were conducted in the month of July 2023 to spread awareness about the health benefits of millets and its usage in daily diet.

4. Global Food Regulators Summit (GFRS) 2023:

i. The first ever Global Food Regulators 2023, organised by FSSAI on 20-21 July 2023, was promoted through social media posts on various platforms, press releases, video testimonials of delegates and media bytes of delegates.

ii. As part of the summit, a cultural program titled 'Anekta me Ekta' was organised, which showcased the diverse cultural heritage of India.

iii. A short corporate film on FSSAI and a film on evolution of global food safety ecosystem have been developed. The videos were showcased during the Global Food Regulators Summit 2023. Another video with the highlights of the 2-day GFRS 2023 was developed.

iv. Food-o-Copoeia, a collection of food category-wise monographs and a single

point reference for all applicable standards for a specific product; 'SaNGRAH' - Safe food for Nations: Global food Regulatory Authorities Handbook and a Common Digital Dashboard were designed and teaser videos for launch were developed.

To promote the use of millets and healthy eating practices among the armed forces and ensure availability of safe and nutritious food, a Memorandum of Understanding (MoU) was signed between the Ministry of Defence (MoD) and the Food Safety and Standards Authority of India (FSSAI) on 13th July, 2023 in the presence of Raksha Mantri Shri Rajnath Singh and Union Health Minister, Dr Mansukh Mandaviya here today. A book titled 'Healthy Recipes for Defence' to promote the consumption of Shree Anna (millets) and its health benefits was also unveiled during the occasion.
