11 Smart Cities as winners of EatSmart Cities Challenge showcase efforts towards Safe, Healthy & Sustainable Food System

New Delhi, March 16, 2022: The Food Safety and Standards Authority of India (FSSAI) in association with the Smart Cities Mission under the aegis of Ministry of Housing and Urban Affairs (MoHUA) announced the winners of EatSmart Cities Challenge in an online event today. The 11 winning cities include Chandigarh, Indore, Jabalpur, Jammu, Panaji, Rajkot, Rourkela, Surat, Sagar, Tumkuru and Ujjain. These cities will now enter into the scale up stage of the Challenge wherein the projects undertaken at the pilot stage will now be scaled up in a sustainable manner.

Launched in April 2021, the EatSmart Cities Challenge aims at motivating Smart Cities to develop and execute a plan that supports a healthy, safe and sustainable food environment through adoption of various Eat Right India initiatives. A total of 108 cities had registered in the challenge out of which 20 cities were shortlisted for evaluation by an external jury panel comprising of national and international experts. 11 cities have been selected as winners for the next phase of scale up and will be awarded Rs. 50 Lacs each by MoHUA. In the scale up stage, cities will adopt an aggressive approach through food systems approach in implementation of various Eat Right India programs at a larger scale. To support the cities, FSSAI along with Food Foundation, UK will organize a series of activities and deliberation sessions to provide technical assistance and showcase their efforts at international forums.

Through this challenge, there has been significant improvement in the overall food ecosystem across the cities. On this occasion, Shri Arun Singhal, CEO of FSSAI, said, "EatSmart Cities Challenge will have a positive impact on the lives of urban population by motivating them to eat right. This Challenge will support a large-scale effort to transform our Country's food ecosystem to one that is safer, healthier and climate friendly. The world is seeking inspiration and innovation from the 11 chosen cities which are the front-runners of this challenge. I appreciate efforts displayed by all the participating cities and hopeful that this will be a game changer in creating massive social and behavioral change towards right eating practices in the years to come."

Manoj Joshi, Secretary, MoHUA said "'As India continues to urbanize at an exponential rate, where every two seconds, one of our fellow citizens is moving to a city in search of a better life, ensuring safe and healthy food for everyone in cities is of utmost importance. It is a matter of pride that today, we see the Eat Right India approach getting scaled up to the Smart Cities level with this Challenge. With the efforts of these 11 cities, we hope to start a movement that inspires all cities to transform their food systems and strengthen the food safety and regulatory environment, building awareness among the consumers and urge them to make better food choices in India's cities."
