CIRCULAR - DEP-04/2025

Sub: Filling up the post of Director in the Food Safety and Standard Authority of India (FSSAI) through deputation on Foreign Service terms-reg.

Food Safety and Standards Authority of India (FSSAI) is a statutory Authority set up under the Food Safety and Standards Act, 2006 for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption.

- 2. FSSAI proposes to fill-up the 3 posts of Director (PL-13) on deputation (including short-term contract) on foreign service terms basis as per the details contained in **Annexure-I** A brief description of duties attached to the post is contained in **Annexure-II**. Applicants fulfilling the eligibility criteria as on closing date of applying online, shall apply online on the link available under the tab 'jobs@fssai(careers)' on the FSSAI website i.e. www.fssai.gov.in commencing from 29.11.2025 to 12.12.2025. The cut-off date for ascertaining eligibility will be closing date of applying online i.e. 12.12.2025. The applications which are not submitted online, within due date, will not be considered.
- 3. The departmental officers in the feeder cadre category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation.
- 4. The hard copy of online application form duly certified by the employer along with "Certificate by the employer/Cadre Controlling Authority" in the prescribed format and other supporting certificates/documents (Integrity certificate, vigilance clearance, major/minor penalty imposed during the last ten years and up to-date duly certified photocopies of detailed APARs for the last 5 years) must reach through proper channel to Assistant Director, Recruitment Cell, FSSAI Headquarters, Room No. 312, 3rd Floor, FDA Bhawan, Kotla Road New Delhi by 19.12.2025 for further necessary action, failing which the candidature may be cancelled. Advance copy of the application will not be considered for scrutiny.

- 5. Those applicants who had applied on the FSSAI's Application portal earlier against deputation notice no. DEP-03/2025 need not to apply again. However, it may be ensured by the applicant that all the documents (countersigned hard copy of finally submitted online application form, certified copy of APARs, NOC, Integrity certificate, Vigilance clearance etc.) shall be submitted through proper channel within current due date of receiving of hard copy of applications, if any of the documents has not been submitted earlier.
- 6. All appointments made on deputation on Foreign Service Terms including short term contract in the Food Authority under these regulations shall be for a period **not exceeding one year** in the first instance, which may be extended **subject to availability of vacancy** as per guidelines issued by the Government of India at the discretion of the Competent Authority which shall be based on the performance appraisal of the candidate and in consultation with the parent department. The deputation in the Food Authority on this post is exempted from rule of immediate absorption. The terms of deputation including pay of the officials selected on deputation will be governed by provisions laid down in the Department of Personnel and Training's Office Memorandum No.6/8/2009-Estt. (Pay II) dated 17th June, 2010 and other orders/guidelines issued in this regard from time to time. The maximum age limit for appointment on deputation shall be **56 years** on the last day of receiving of the online applications.
- 7. Officials of other Departments, Autonomous Bodies etc. where salaries are paid on IDA basis may kindly refer to the IDA-CDA Equivalency issued by FSSAI as per **Annexure-III** for ascertaining their eligibility for various posts on Deputation.
- 8. The applicants are further informed that once application is submitted, they will not be allowed to withdraw their candidature subsequently.
- 9. The vacancies shown in the advertisement are indicative which may increase or decrease at the discretion of the Competent Authority. The Food Authority reserves the right not to fill up all or any of the vacancies or to cancel the advertisement at any stage. Brief Job description/duties for the post Director

At Headquarters, New Delhi

Directors work under the guidance and supervision of Executive Director or Advisors. They hold charge of a Division (s) and is responsible for discharge of assigned work of the Division by associating other officers and staffs of the Division.

Further, they are responsible for implementing policies, ensuring compliance with Food Safety and Standards Act, 2006, Rules and Regulations made thereunder besides following Govt. of India rules, guidelines, instructions etc. as applicable. They are also responsible for exercising oversight and supervision, and reporting to the higher authorities. Their role requires careful decision-making, effective communication, and a focus on achieving organizational objectives.

At Regional Offices of FSSAI and National Food Laboratories i.e Kolkata, Ghaziabad, Mumbai and Chennai

The Director at Regional Offices oversees Central Licensing Authorities and Central Food Safety Officers, ensuring time-bound processes and adherence to targets such as licensing functions, inspections, sampling, enforcement, and action on violations. They review the status of prosecution and adjudication cases, coordinate with States, manage grievances, and monitor food recalls. The role includes ensuring fair sample distribution to labs, import-clearance oversight, financial propriety, HR administration, and training implementation. They supervise IT assets, legal and vigilance matters, and execute behavioural change campaigns and regular reporting to FSSAI HQ. The Regional Director ensures efficient regulatory operations and compliance across the assigned region.

The Director of an FSSAI National Food Laboratory oversees overall laboratory operations, ensures quality-controlled and accredited testing, manages staff, maintains regulatory compliance, supervises analytical methods and equipment, handles financial and procurement matters, supports enforcement and surveillance activities, coordinates with FSSAI HQ, and ensures timely, accurate food testing and reporting. Apart from the above duties, Director of NFL is also responsible for signing of Lab reports of Referral Sample as per Food Safety and Standards Rules, 2008

OFFICE MEMORANDUM

Sub: IDA-CDA equivalency for various posts of FSSAI on DR and Deputation Basis

The equivalence of CDA vis-à-vis IDA pay scale for the purpose of recruitment on DR and Deputation basis was issued by FSSAI in the past and same has been available on FSSAI website under FAQs on FSSAI Recruitment.

- 2. The issue regarding equivalence of pay scales has been deliberated by the committee constituted by FSSAI and taking into consideration the equivalence of pay between CDA and IDA Pay scales adopted by other Public Sector Enterprises/ Undertakings/ Autonomous Bodies such as WCD/DOPT, NHAI, Indian Railway Stations Development Corporation Ltd., FCI and UIDAI, the committee has recommended the equivalent pay scale as indicated at para 3 below.
- The recommendations of the Committee have been approved by the Competent Authority and accordingly, in supersession of the earlier equivalency, the following revised equivalence of CDA vis-à-vis IDA pay scales are being adopted in FSSAI for future recruitments.
