1. Proposal of the EOI

FSSAI invites EOIs for Printing & Supply of Certificate for Food Safety Supervisor under FoSTaC Programme for Food Safety and Standards Authority of India. This organisation invites EOIs from experienced and well established agencies/printers having GST and PAN No. and who are ready to provide their services with due care and guidance to FSSAI/NULM so as to get maximum utilization of resources within the stipulated time. FSSAI will reimburse the amount with due verification, as deemed fit, considering the number of printed certificates supplied as well as courier/transport charges to the designated places/offices.

2. Scope / Description of Work

2.1 As stated above, FSSAI intends to get the certificates printed & supplied to the desired location. Total number of certificates will be appx 02 lakh. Certificates for Food Safety Supervisor under FoSTaC Programme will be generated from FoSTaC portal after the completion of the training sessions of Food Handlers as mentioned in proposal. (a) Quantity : Approx. 02 Lakh

(b) Quality : 250 GSM

(c) Coating : Glass varnish/coating

(d) Colour : Multicolour

(e) Size : A4

2.2 Mode of Supply:

- (a) Certificates (with the name of trainee along with other details) will be downloaded from the FoSTaC portal after completion of the training and soft copy of the certificate will be shared with the vendor. Vendor will print the certificate as per the agreement. This is to be noted that, no blank Certificate will be printed and supplied.
- (b) Certificates will be supplied to the location (especially to the office of the urban local self-government) as directed by NULM. Printers will have to ensure the supply the certificates at the designated places with their courier partners.

3. Eligibility Criteria

The agencies/printers who fulfil the following eligibility criteria shall be eligible to apply.

- Have done similar works with any Govt. Agencies.
- b. Have a Registered Office
- c. Have mandatory registration No. such as GST council, Income Tax Deptt etc.
- d. Agencies/Printers that are debarred or blacklisted by any Govt. Departments or any other organisation/Society whatsoever are not eligible to participate in the process.

A Certificate is to be submitted along with the EOI by the Agencies/Printers to the effect that they are not debarred or blacklisted by Central Govt., FSSAI or State/UTs Govt. or by Court of Justice and neither any case is pending or under investigation on charges of corruption, unfair trade practices, mishandling/abusing participants/users. In the event of any false information or/and on revealing of any such fact later, even if work is awarded, it shall be withdrawn.

- e. **Desirable**: Having LOI/MOU/Agreement with any of courier company.
- 4. <u>Pre-Bid Conference:</u> A Pre-Bid Conference shall be held at FDA Bhawan, 3rd Floor Conference Room, Kotla Road, New Delhi -110002 on 31st March, 2021 at 1430hrs. All prospective bidders are requested to kindly attend the Pre-bid Conference. In order to facilitate bidders, for proper conduct of the Pre-bid Conference, all prospective bidders are requested to kindly reach the venue at the given date and time. FSSAI shall answer the queries during the pre-bid conference, which would become a part of the proceedings of the Pre-Bid Conference. These proceedings will become a part of clarifications / amendments to the bidding documents and would become binding on all the prospective bidders.
- **5.** <u>Bid Security/Earnest Money Deposit:</u> No Bid Security / Earnest Money Deposit will be required along with EOI.

6. Performance Security:

- (a) Three percent of the value of the contract as specified in the bid documents will be required to be furnished, as Performance Security, in the form of an Account Payee Demand Draft, Fixed Deposit Receipt from a Commercial bank, Bank Guarantee from a Commercial bank or online payment in an acceptable form.
