Status of Food Safety on Wheels (as on 31.03.2022)

- 1. FSSAI is providing Food Safety on Wheels (the mobile labs) under CSS to the States/UTs. Under this component, a fully fabricated vehicle (along with equipment) costing ~Rs.30 lakh (approx.) excluding GST, has been provided to States/UTs besides a recurring grant of Rs.5 lakh/year for three years towards fuel and consumables. The amount of grant has been increased to Rs. 10 lakh/year/FSW. States are required to perform all the 3 key activities viz. testing, training and awareness through FSWs. All the 60 FSWs have been operationalized by the States/UTs during the period.
- 2. Towards scaling up of food testing, awareness and capacity building as per the vision document, a new version of FSW called modified FSW has been designed. A fully fabricated modified FSW (along with equipment, a few hand-held devices/rapid kits and microbiological testing) costing ~Rs.35lakh (approx.) excluding GST, is being provided to States/UTs besides a recurring grant of Rs.5 lakh/year/FSW for two years towards manpower, fuel, consumables, internet facility, and other operational expenses etc. The amount of grant has been increased to Rs.10 lakh/year/FSW.

So far, 173 modified FSWs have been sanctioned on first come first serve basis, subject to readiness of the state governments, out of which 160 modified FSWs have been delivered to 33 States & UTs. For rest of 13 FSW, advance fund @ Rs.42 Lakh per FSW, for procurement from GeM, has been sanctioned to the State of West Bengal (1), Jammu & Kashmir(6), Uttar Pradesh (3) & Karnataka (3). FSSAI is also in the process of providing more funds for such procurement to the States & UTs. The objective is to station one FSW in every district to increase the outreach and thus testing.

In addition, as we do not have any provision of providing more FSWs under the CSS scheme, the FSWs is proposed to be included in the MoU/Workplan being signed by the States with FSSAI.

- 3. FSW may also be utilized for following activities
 - a. As a cold chain logistics for regulatory / surveillance sample,
 - b. As an offsite wing of Labs,
 - c. As a handy tool for training street food vendors and petty FBOs from all kind of business.
 - d. Providing information and support for licensing and registration, with special emphasis on petty FBOs, street vendors etc.
 - e. Training and/or awareness programs for plantation workers about food safety,
 - f. Training and awareness program for students, FBOs and public. FSW may be used as an effective tool in connecting and sensitizing the public at large with the 'Eat Right India' campaign.
 - g. As a module for communicating IEC materials in vernacular languages,
 - h. Any other creative measures that can be undertaken.
 - i. States/UTs are to furnish Monthly Progress Report by 7th day of every month.
