1.3 As part of enforcement measure, following orders/directions were issued by FSSAI to conduct special drives:

- June 2024 enforcement and surveillance drive on Milk & Milk Products
- July 2024 enforcement drive on Fresh Fruits & Vegetables
- August 2024 enforcement drive on Fish, meat, poultry & egg
- September 2024 enforcement drive on Pulses & food grains
- October, 2024 enforcement drive on Verification of compliance to Labelling & Display regulations

1.4 Recent Initiatives / Schemes:

- (i) Launch of Instant (Tatkal) issuance of License / Registration: Effective from 31st August 2024, the scheme of instant (Tatkal) license / registration covers specific categories such as Wholesalers, Distributors, Retailers, Transporters, Storage without Atmospheric Control, Importers, Food Vending Agencies, Direct Sellers, Merchant-Exporters, Petty Retailers and Hawkers. Till 11.11.2024, 3,922 Licenses and 50,589 Registrations have been issued under this provision.
- (ii) Waiver of Registration fee for Street Food Hawkers: As per Section 31 of the Food Safety and Standards Act, 2006, all street food hawkers are required to register themselves with FSSAI, with a nominal fee of Rs.100 per year. To encourage hawkers to get registered with FSSAI, fees specified for hawkers has been waived off w.e.f 28th September, 2024 with a 5-year validity period.
- (iii)Revision of the auditor manual regarding the specified limit on the maximum number of audits an auditor can conduct annually: To enhance the efficiency of audit agencies and in order to ensure the audit of high risk food manufacturers, the

existing capping of 50 audits per year subject to maximum of 100 man-days per year has been removed.

- (ii) Food Safety and Standards (Contaminants, toxins and Residues) First Amendment Regulations, 2024 relating to tolerance limit of antibiotics and crop contaminants; and
- Food Safety and Standards (Food Products Standards and Food Additives) (ii) First Amendment Regulations, 2024 relating to revision of standards for Khoa, colostrum and other dairy products; Standard for crude solvent extracted corn oil, revised standard for peanut butter, aeration in bakery shortening and fatty acid composition of olive oil; Definition of pickles & description of minimally processed vegetables; Revision of standards of rice related to pin pint damage; Standards related to fortified rice kernels (FRK); Revised standard of pickled eggs; Standards for Fish Oil; Standards for Dried Parsley; Standards for Tea; Radiation processing of some food; Standards for Oligo-fructose; Microbiological standards for Baker's Yeast and Microbiological standards for Neera;

- (i) Draft Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2024 relating to Inclusion of "Natamycin" in Food Category 1.2.1.1 and 1.7;
- (ii) Draft Food Safety and Standards (Fortification of Foods) Amendment Regulations, 2024 relating to omission of advisory on Thalassemia and Sickle Cell Anaemia;
- (iii) Draft Food Safety and Standards (Contaminants, Toxins and Residues) Amendment Regulations, 2024 relating to comprehensive revision of MRL of pesticide;
- (iv) Draft Food Safety and Standards (Contaminants, Toxins and Residues) Amendment Regulations, 2024 relating to limits of metal contaminant, Crop contaminants & naturally occurring toxic substances and antibiotic;
- (v) Draft Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2024 relating to milk fat composition, fermented milk, Haleem, garam masala, dried peppermint, Indigotine and processing aids;

- (vi) Draft Food Safety and Standards (Import) Amendment Regulations, 2024 relating to revision in Reference of Methods of Analysis and Signing Authority for primary & appeal samples;
- (vii) Draft Food Safety and Standards (Licensing and Registration of Food Business) Amendment Regulations, 2024 relating to hygienic requirement for primary producer and provision of digitisation of license & registration;
- (viii) Draft Food Safety and Standards (Prohibition and Restrictions on Sales)
 Amendment Regulations, 2024 relating to omission of restriction related to
 Salseed fat; have been published in the Gazette of India for inviting
 comments and suggestions from stakeholders.

4.1 Number of FSSAI-Notified Laboratories:

The total number of primary food testing laboratories notified u/s 43(1) of the FSS Act, 2006 is 242 (Annexure - II) and the total number of Referral Labs u/s 43(2) of the FSS Act is 22 (Annexure - III).

4.2 Food Safety on Wheels (FSWs): (Annexure - IV)

4.3 Surveillance during festive season

In the state of Uttar Pradesh, samples of mustard oil, sunflower oil, and rice bran oil were collected. These samples failed the rapid test conducted by FSW. In this way, a total of 32.5 tons of edible oil valued at ₹55,93,000 were seized.

4.4 Test Reports uploaded by FSSAI notified laboratories on INFoLNET portal (June 2024 to October 2024):

4.5 50% reduction of testing fee for PAN India surveillance programs:

Accordingly, an **order** was issued on **11.09.2024** to implement the 50% fee reduction for FSSAI surveillance activities.

5 STREET FOOD VENDOR PORTAL

- In July 2024, a dedicated portal for street food vendors was launched by Union Health Minister Shri Jagat Prakash Nadda.
- This portal aims to empower street food vendors by providing a platform to share their success stories, access valuable resources on food safety, and engage with the community.

6 LAUNCH OF FOOD IMPORT REJECTION ALERT (FIRA) PORTAL

• The Food Import Rejection Alert (FIRA) portal were developed and launched as a critical tool for the rapid exchange of information on food import rejections at Indian

- borders. This portal aims to strengthen global collaboration on food safety and ensure that only safe and quality food products enter the Indian market.
- Currently, 9 alerts have been published in the FIRA portal for food items from Sri Lanka (2), Japan (3), Turkey (1), and China (2) since January 2024. The items that were rejected were Non-alcoholic beer, Sushi Nori, Arecanut, Fresh Apples, Tea bag, and Cinnamon Flower bud.

7 TRAINING AND CAPACITY BUILDING

FoSTaC progress

Till 23rd October 2024, a total of 54,004 trainings have been conducted under the FoSTaC program and more than 19.76 lakh people have been trained. Since, the last authority meeting, i.e., from 19th June 2024 to 23rd October 2024, about 2.5 lakh food handlers were trained through 4,306 training events.

Training and Awareness program for 1000 Street Food Vendors was conducted on 20th July, 2024 at Vigyan Bhawan, New Delhi. This event was graced by Hon'ble Minister of Health and Family Welfare Shri. J. P. Nadda, Smt Anupriya Patel, Hon'ble Minister of State, MoHFW and Minister of State, Ministry of Chemicals & Fertilizers, Shri Apurva Chandra, Health Secretary, MoHFW, & Chairperson FSSAI and Hon'ble CEO, FSSAI. In this event the critical importance of training the street food vendors across India was emphasised.

The 13 episodes aim to promote millet-based recipes to boost nutrition awareness.
- **9.2 Eat Right Quest on MyGov** To raise awareness about safe and healthy diets, the Food Safety and Standards Authority of India in collaboration with MyGov launched a quiz competition titled "Eat Right Quest" in the month of August. The competition aimed to engage and educate public on the importance of making informed food choices and promoting a culture of health and safety in dietary habits. The quest culminated on 4th October 2024. Around 40,000 people participated in the Quest.

- **9.3 Eat Right Quiz on Social Media** After the successful completion of Eat Right Quest on MyGov, FSSAI launched Eat Right Quiz on 6th October 2024 on its social media handles to create awareness regarding healthy food habits.
- **9.4 Food Safety Awareness Campaign on Independence day** FSSAI ran a campaign from 15th August 2024 to 14th September 2024 on FM radio channels across the country for brand building and to create awareness regarding food safety.
- **9.5 360 Degree Media Campaign** A month-long food safety awareness campaign was launched on 29th October 2024 to cater to the festive season on FM radio (Metros and tier 2 cities), LED/LCD Screen at Airport (Delhi) and Audio Announcement at Railway Stations (Pan India).
