Status of Setting up / Up-gradation of of Microbiology Laboratory in State Food Laboratories (as on 01.04.2021)

FSSAI is implementing a Central Sector Scheme for "Strengthening of Food Testing System in the Country Including Provision of Mobile Food Testing Labs" (SOFTeL) with a total outlay of Rs. 481.95. The time frame for implementation of the Scheme is 2016-17 to 2018-19. Proposal for extension of the scheme is under consideration with Ministry of Health & Family Welfare, New Delhi.

The scheme *inter alia* envisages strengthening of 45 State Food Testing Labs. At least one food testing laboratory in each State and two in larger States would be assisted. Under this scheme, one of the subcomponent is 'Setting up of Microbiological laboratory' under the component of 'Upgradation of State Food Testing Laboratory' at an estimated cost of Rs.1.00 (one) Crore. This would enable the States/UTs to analyse the regulatory and surveillance samples drawn by the FSO within the shortest possible time frame; to analyze Microbiological tests; to ensure compliance of FSSAI standards on food; to become a resource point for training and facility up-gradation for other existing Government / Public Food testing laboratories in the State; and to introduce online laboratory data management system through Laboratory Information Management System (LIMS). For implementation of the scheme, FSSAI had sanctioned and released Rs. 1 (one) crore to those States/UTs wherein proposal was received and approved by the experts.

Now, FSSAI is in the process of finalization of Rate Contract (including manpower) for setting up of microbiology laboratory on turnkey basis in States/UT. The list of empanelled vendors, along with terms and conditions of empanelment and standard format of order will be shared with States/UTs, besides uploading on the website of the FSSAI. The scope of the work under the Rate Contract includes following components -

- Supply, installation and commissioning of microbiology laboratory equipments.
- Supply of media and consumables
- Erection of Clean Room
- Carry out associated Civil and Electrical Work
- Supply of Manpower.
- Maintenance of Microbiology Laboratory during the contract period.

Requests have been received from various states for setting up of microbiological labs on turnkey basis under the RC. So far, 26 State Food Safety Laboratories of 19 States/UTs have been considered for setting up of microbiology laboratories under the old scheme and recently finalised RC. A total Grant in aid of Rs. 24.33 crore has been released to these SFTLs for the said purpose. State-wise details are as under (as on 01.04.2021).
