The Food Safety and Standards Authority of India (FSSAI) is an autonomous statutory Authority set up under the Food Safety and Standards Act, 2006 for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption.

- 2. FSSAI proposes to fill the positions on transfer on deputation on Foreign Service terms as per the details contained in <u>Annexure–I</u>. Officers fulfilling the eligibility criteria & experience as stipulated in <u>Annexure–I</u> may apply in the prescribed format (<u>Annexure–II</u>) through proper channel. The candidates who fulfil eligibility criteria and possessing requisite experience may apply in the prescribed format (<u>Annexure-II</u>) alongwith the supporting documents.
- 3. The period of deputation would be initially for a period of three years. This can be extended further by upto 2 years in public interest. However, in exceptional circumstances, the deputation would also be considered for one year which may be extended further for upto two years. The terms of deputation including pay of the officials selected on deputation will be governed by provisions laid down in the Department of Personnel and Training's Office Memorandum No.6/8/2009-Estt.(Pay II) dated 17th June, 2010 and other orders/guidelines issued in this regard from time to time. The period of deputation, in case of employees already on deputation in another ex-cadre post including, the period of deputation held immediately preceding this appointment in the same or some other organization/Department shall not exceed five years. The maximum age limit for appointment on deputation shall be **56 years** on the last day of receiving of the applications.

4. Applications alongwith declaration duly signed and accompanied by the requisite personal data in Annexure-II supported by certificate/documents should be reached to the Assistant Director (Estt), Food Safety & Standards Authority of India, FDA Bhavan, Kotla Road, New Delhi-110002 on or before 21st March 2016.
