The Food Safety and Standards Authority of India (FSSAI) is an autonomous statutory Authority set up under the Food Safety and Standards Act, 2006 for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption.
- 3. The Pay of the officials selected on deputation will be governed by provisions laid down in the Department of Personnel and Training's OM No. 2/8/97-Estt.(Pay-II) dated 11.3.1998, as amended from time to time.
- 4. The period of deputation, including the period of deputation in another ex cadre post held immediately proceeding this appointment in the same or some other organization/Department shall not exceed three years. The maximum age limit for appointment on deputation shall be 56 years. Accordingly persons who will be crossing the age of 56 years, on the last day of receiving the applications need not apply.
